The dune lizard listing has been postponed for six months! What a Divine intervention and miracle! Our prayers have made it to the throne room of God and we have truly penetrated the wall of darkness. Please take note how God is speaking to us as intercessors. The Lord spoke to me in prayer early in the morning during Thanksgiving to call a national prayer meeting with our intercessors and believe for the radical environmentalists to be exposed. This included Secretary of the Interior Ken Salazar and Dan Ashe, Director of Fish & Wildlife. They have a \$12 billion budget to push their extreme environmentalist agenda purposed to deny access to American oil and mineral resources for drilling. Obama has appointed heads of departments who are as determined as he is to "stop global warming" by any means necessary.

I did not sleep for weeks over the fact the lizard listing appeared to be a done deal. I knew the ramifications of such a deal and the destruction it would cause. It was a terrible burden to bear. When I went to Artesia, New Mexico this past April, I was informed of this threat of land confiscation. There were so few people aware of it that I wanted to make sure I joined the fight and help get people informed. I would tell people what was happening and they didn't believe it. I knew it was so bazaar people couldn't believe it. "Not in America." How wrong they were! I am convinced Obama had set December 14th as the day to destroy our energy resources and collapse the economy altogether. The State of New Mexico will go bankrupt if the lizard and prairie chicken are ever listed as endangered species.

The Lord said if He has one intercessor He will turn back the judgment on the land. On December 3rd, we stood in the gap. Once again, the date and timing was prophetic.

First, I got an email from Attorney Karen Budd-Falen thanking me for calling a prayer meeting and informing me that she would be in DC on December 6th testifying before a Congressional committee investigating the abuse of the Endangered Species Act by nonprofit environmental groups. She is going up against the racketeers that have extorted millions of federal tax dollars in the name of "environmentalism." Congress left a legal loophole in legislation that allows these groups to file thousands of bogus law suits and do nothing but collect attorneys' fees as a cash cow. But, it's our money and our lands they are playing with! The Judgment Fund must be dissolved. The cash cow needs to dry up! Our work is not finished!

In God's timing, the Action Alert went out on November 28th just as Rep. Steve Pearce along with 17 other members of Congress signed off on a letter to Secretary Salazar requesting the dune lizard not be listed as endangered. This was on November 30th. I just want you to see how the Holy Spirit directs our steps.

I received another email stating over 400,000 people had joined a Midland grassroots effort and sent Obama emails that the dune lizard not be listed. Of course, no one received a reply. Thousands petitioned elected officials to stop the listing and save the oil fields.

In the summer, Senator John Cornyn (TX) tried to amend the Endangered Species Act with little

support from the Senate, especially Leader Harry Reid. Weeks before that, Rep. Pearce appealed to the House with no luck. As this was going on, the Dept. of Interior paid \$30 million to WildEarth Guardians. In July, Attorney General Eric Holder allocated \$206 million for reviewing environmental law suits. The \$206 million did not include attorneys' fees being paid out to Obama's green friends.

We've been set up and robbed by thieves with college degrees. White-collar criminals. We are victims of crime and the victims must unite and protect their property.

I said that contacting Obama and members of Congress was useless in stopping the listing. We had to go straight to the source---the Director of Fish & Wildlife Dan Ashe and Secretary Salazar. Back in September no one really knew who these two were or how to contact them. We were just being told "contact the Director." But no name was being put forward. I thought "who is this mystery man?" If he has this much power, we certainly need a name!

So, I prayed and called the Dept. of Interior to see who was authorized to make the determination of the listing. I was told Director Dan Ashe. It took three calls to get the information needed. Thus I began to publicize his contact information including on my television broadcast. I got the word out exactly who to pray over and the players involved. When our calls began bombarding Salazar and Ashe's offices, Rep. Pearce's letter arrived on their desks. I had no idea Rep. Pearce had sent the letter. The Lord's fingerprints are all over it! He speaks to His people. To Him be the glory!

My question is "why didn't a majority of Congress sign this letter?" Can you see why our country is on a collision course? Our work has only just begun.

Just postponing the listing for six more months is not going to be acceptable. This whole racket must be exposed and "thrown in the dumpster forever." Those who spent money fighting this should file to be reimbursed. I'm praying for attorneys who can help us and represent the victims.

The Operation Battle Cry has been a wonderful success. We have won a battle. Now it's time to win the war!
