On December 14th, 660,000 acres of privately owned, oil producing lands in Texas and New Mexico will be awarded to the Sand Dune Lizard compliments of the Feds.

Recent millions in taxpayer revenues have been awarded to "green" organizations via law suit settlements all the while Obama demands Congress to raise the federal debt ceiling again in February 2012. Then there was the spotted owl, no one ever saw, that the feds used to close down saw mills and logging. More workers lost their jobs because of an owl. Where was the media backlash? Who is looking out for the working man? The cries of the victims, those who lost livestock, horses, and ranch land fell on deaf ears. My heart broke for them. I actually did several television shows focusing on their plight and exposing the abuse of power. Our prayer teams prayed many prayers on this issue and asked God for deliverance.

Like many Americans, I knew nothing about the day-to-day activities of federal agencies and the power they have over us. My quest to find the truth concerning their abuse of power and their enormous budgets has brought me to this moment. Learning of the gray wolf and the spotted owl was just the tip of the iceberg.

In April, I was hosting an Insight prayer rally in Artesia, New Mexico. This is where I was introduced to the battle being waged against drilling our domestic energy sources there. The environmentalists, including Obama, are fighting hard to close off our domestic energy resources by any means necessary. At the meeting, County Commissioner Chairman Derrick Lewis spoke and asked us to pray for the citizens who would be victims if the sand dune lizard and prairie chicken are listed as endangered species in December 2011. If so, over 660,000 acres of oil lands will be restricted and off limits to drilling. This move to list these species has been in the works since 2008. It's taken four years, but the hour has come. Tens of thousands of dollars in attorneys' fees have been paid by New Mexicans to try and stop this. Yet, the listing is scheduled for December 14, 2011.

We have all been stunned by this move of the feds and have wondered how could this be happening? Again, where is the national media coverage? Under Governor Richardson's administration the greens had full clearance to implement their plans. Currently, Rep. Steve Pierce is fighting back along with many others. Without a miracle, Obama and the environmental extremists will celebrate another victory.

I need everyone's help. Let me explain what I've learned about how this happens, who is involved, and what we can do to stop it in the future.

Activist Environmental Lawyers Bilking Millions from Taxpayers

Without any oversight, accounting, or transparency, environmental activist groups have surreptitiously received at least \$37 million from the federal government for questionable "attorneys' fees." The lawsuits they received compensation for had nothing to do with environmental protection or improvement.

The activist groups have generated a huge revenue streams via the obscure Equal Access to Justice Act. Congressional sources claim the groups are billing for "cookie cutter" lawsuits --- they file the same petitions to multiple agencies on procedural grounds and under the Act, they file for attorney's fees even if they do not win the case. Since 1995, the federal government has neither tracked nor accounted for any of these attorney fee payments.

Nine national environmental activist groups alone have filed more than 3,300 suits, every single one seeking attorney fees. The groups have also charged as much as \$650 per hour (a federal statutory cap usually limits attorney fees to \$125 per hour).

In well over half of the cases, there was no court judgement in the environmental groups' favor. In all cases, whether there was any possible environmental benefit from the litigation is highly questionable. Most cases were simply based upon an alleged failure to comply with a deadline or to follow a procedure. A whistleblower who was employed for 30 years by the U.S. Forest Service told Pajamas Media: Some organizations have built a business doing this and attacking the agencies on process, and then getting "reimbursed."

This week a bipartisan group of congressional members introduced legislation to end the secrecy of the payments and force the government to open up the records to show exactly how much has been paid to the groups and the questionable attorney fees. The legislation was sponsored by Rep. Cynthia Lummis (R-Wyoming), Rep. Stephanie Herseth Sandlin (D-SD), and Rep. Rob Bishop (R-Utah).

Congressional sources have said the disclosure was necessary to determine the extent of fraud and abuse. The \$37 million is considered only a fraction of what has been paid out to the activist groups. "For too long, taxpayers have unwittingly served as the financiers of the environmental litigation industry," Rep. Bishop, who also is the chairman of the Congressional Western Caucus, said. Rep. Herseth Sandlin remarked: "Simply put, this legislation is about ensuring good and open government."

"It's time to shine some light [on the program]," explained Rep. Lummis, who said the groups have created an industry that "supports their 'stop everything' agenda."

The \$37 million figure is considered low. It includes less than a dozen groups and only accounts for cases in 19 states and the District of Columbia. There are hundreds of eco-activist groups in the United States.

According to the whistleblower who served in the U.S. Forest Service, environmental activist groups typically file identical lawsuits to multiple agencies on procedural grounds, such as a missed deadline.

Hundreds of Groups Shaking Us Down

The identity of the huge revenue stream was established by the Western Legacy Alliance ("WLA"), along with Wyoming-based attorney Karen Budd-Falen. Western Legacy Alliance was founded in 2008 by ranchers and resource providers who raise beef and lamb on public lands of the West.

What they found was astounding.

Examining court records in 19 states and in the District of Columbia, the total amount paid to less than a dozen environmental groups exceeded \$37 million. "This is just the tip of the iceberg," says Budd-Falen. "We believe when the curtain is raised we'll be talking about radical environmental groups bilking the taxpayer for hundreds of millions of dollars, all allegedly for 'reimbursement for attorney fees.' And what is even more maddening is that these groups are claiming that they are protecting the environment with all this litigation when not one dime of this money goes to projects that impact anything on-the-ground related to the environment. It just goes to more litigation to get more attorney fees to file more litigation."

The whistleblower, speaking anonymously, told Pajamas Media the payments to the activists groups were "quite astronomical." The former government agent was a line officer in a high-ranking position. That whistleblower added that the filings by the radical groups often were "canned" petitions that contained little research. In this way, environmental groups could pepper government agencies with a flood of lawsuits without much work.

This is How They Work the System

"They will send a myriad of lawsuits across the bow to try to stop a number of projects or programs and then they hopefully will score with one or two," he said. He saw a lot of the activist lawsuit filings because he had been attached both to the Forest Service's Washington headquarters and to its field offices. "Then they will send in bills that are quite frankly, quite astronomical compared to the actual work they had to do to file an actual lawsuit. Many of the lawsuits are filed under a lot of canned material, yet the hours and rates that they charge were quite high."

Here is a sampling of the number of assembly line "lawsuits" filed between 2000 and 2009 that have been painstakingly identified by the Western Legacy Alliance and Attorney Budd-Falen.

- Activist group Western Watersheds Project filed 91 lawsuits in the federal district courts;
- Forest Guardians (now known as WildEarth Guardians) filed 180 lawsuits;
- The Center for Biological Diversity (CBD) filed at 409 suits;

- The Wilderness Society filed 149 lawsuits;
- The National Wildlife Federation filed 427 lawsuits; and
- The Sierra Club filed 983 lawsuits. These numbers do not include administrative appeals or notices of intent to sue. Even local or regional environmental groups have figured out ways to turn on the taxpayer spigot.
- WLA found the Idaho Conservation League filed 72 lawsuits and
- The Oregon Natural Desert Association filed 50.
- The Southern Utah Wilderness Alliance filed 88 lawsuits.
- At last count, just eight local groups in nine Western states have filed nearly 1,600 lawsuits against the federal government.
- On the national level, over the last decade nine national environmental groups have filed 3,300 cases against the federal government. As is usual, the vast majority of the cases deal with the alleged procedural failings of federal agencies, not with substance or science. Said the Forest Service officer: "A lot of times they will sue on process, and not on substance. And substance means what difference does it mean for the resource, or what's going on on the ground? A lot of times, it will be a process law-suit and a lot of times the agency either missed something... The bottom line is many, many times, when you look at the results on the ground, it [the environmental group winning the litigation] would have made very little difference."

Radicals Rip-Off

Karen Budd-Falen said that the cases amounted to a rip-off of taxpayers and rewarded radical groups with millions of dollars. "Although those of us involved in protecting property rights and land use in the West were aware that radical groups were getting exorbitant fees simply by filing litigation against the government, we had no idea of the magnitude of the problem."

Budd-Falen highlighted one case that typifies the gravy train that has flowed to environmental groups. In 2009, the Earthjustice Legal Foundation represented the Defenders of Wildlife, The Sierra Club, The Wilderness Society, and the Vermont Natural Resources Council in a case dealing with the process used by the Forest Service to adopt some regulations. The Earthjustice Legal Foundation filed for attorney fees for that single case that took only one year and three months to complete. The same suit was filed by the Western Environmental Law Center on behalf of other environmental groups. **The seven total attorneys who worked on the case billed the federal government \$479,242. They charged between \$300 to \$650 per hour, far above the statutory federal cap of \$125. The case was resolved at the district court level and the federal government did not appeal.**

The Center for Biological Diversity (CBD) also files a significant amount of litigation and receives lucrative attorney fees.

In Washington State Federal District Court alone, CBD received attorney fees totaling \$941,000 for only six cases. In the District of Columbia, it received more than \$1 million in fees.

One of the fourteen groups, the Center for Biological Diversity, called the two Republicans and one Democrat “rabid right-wingers” and said that the charges of abuse were “patently false and patently ridiculous,” according to Bill Snape, senior council for CBD.

Another study from Virginia Tech University discovered similar findings as a result of a comprehensive Freedom of Information Act request to five federal agencies. The Virginia Tech study also revealed that two of the agencies could provide absolutely no data on the Act's payments.

Environmental organizations are among the most financially prosperous non-profits in the country. The Sierra Club alone in 2007 reported its total worth as \$56.6 million. According to 2007 Internal Revenue Service records, the top ten environmental presidents receive as much as a half million dollars a year in annual compensation. Fred Krupp, the president of the Environmental Defense Fund, Inc reported \$492,000 in executive compensation in 2007. The top ten highest grossing environmental executives all received at least \$308,000 in compensation.

Environmental activist groups also have been among the most influential in throwing around political money. According to the Center for Responsive Politics, **between 2000 and this year activist environmental political action committees have given \$3.4 million in campaign contributions to candidates for federal office. About 87% of the money went to Democrats.**

Daniel M. Ashe was confirmed on June 30, 2011 as the 16th Director of the U.S. Fish and Wildlife Service, the nation's principal Federal agency dedicated to the conservation of fish and wildlife and their habitats.

Ashe also served as the Science Advisor to the Director of the Fish and Wildlife Service. As Science Advisor, Ashe led an organizational renaissance for science leading the Service's efforts to respond to changes in the global climate system; shaping an agency agenda for change toward a science-driven, landscape conservation business model; defining an agency Code authoring new guidelines for scientific peer review and information quality; He was also responsible for leading efforts to build stronger relationships with the U.S. Geological Survey.

This is the man that is planning to list the sand dune lizard an endangered species in New Mexico on or before December 14th. He is touted to be an authority on scientific review and information quality. He also is building strong relationships with the U S Geological Survey.

The push to list the lizard began four years ago. It started with a letter with intent to sue. Following is a transcript of the original letter:

Dear Secretary Kempthorne and Director Hall,

Pursuant to the Endangered Species Act (“ESA”) and the Administrative Procedure Act (“APA”), WildEarth Guardians hereby petitions you to list the sand dune lizard (Sceloporus arenicolus) on an emergency basis under the ESA. 16 U.S.C. § 1533(b)(3)(C)(iii) and § (b)(7) (emergency listing authority of the ESA) and; 5 U.S.C. §553(e) (right to petition under the APA). Under the ESA, the Secretary “shall implement a system to monitor effectively the status of all species,” such as the sand dune lizard, which the Secretary has determined are warranted, but precluded from listing, 16 U.S.C. § 1533(b)(3)(C)(iii), and “shall make prompt use

of the authority under [16 U.S.C. §1533(b)(7) (emergency listing authority)] to prevent a significant risk to the well being of any such species.” 16 U.S.C. § 1533(b)(3)(C)(iii). The APA allows any citizen to petition an agency for the issuance of a rule or regulation within the agency's power.

In addition, we hereby provide you with formal 60-day notice of our intent to file suit under the citizen suit provision of the ESA, 16 U.S.C. § 1540, contending that your finding in the December 6, 2007 Candidate Notice of Review, 72 Fed. Reg. 69034- 69106, that the sand dune lizard does not warrant emergency listing under the ESA was

arbitrary and capricious in violation of the ESA and APA. 16 U.S.C. § 1533(b)(3)(C)(iii) and § (b)(7); 5 U.S.C. § 706(2)(A).

If you do not reverse this arbitrary finding or indicate firm plans to list the sand dune lizard immediately, WildEarth Guardians intends to file suit, no sooner than 60-days from today's date, to address your violations of the law.

While Director Hall stated to Congress on February 28, 2008 that the Service would issue a proposed listing determination for the sand dune lizard in 2008 and a final listing determination in 2009, we have no basis for believing that the sand dune lizard will actually be listed under the ESA within this timeframe given the U.S. Fish and Wildlife Service's (Service's) past behavior.

The Service is unlikely to meet self-imposed deadlines for action and offers only the possibility of protection in 2009 rather than certainty that the lizard will actually be listed.

Our petition and potential lawsuit seek to force certain protection in 2008.

Submitted April 9, 2008.

Moreover, based on information already in the Service's files it is clear that there will be “significant risk to the well being” of the sand dune lizard if it is not immediately listed under the ESA. This significant risk stems from ongoing impacts to lizards and their habitat due to poorly regulated oil and gas exploitation, shinnery oak removal, off-road vehicle use, toxic fumes, and other factors that are compounded by the extremely narrow range of this species.

In short, as leading scientific researchers and agency biologists have recognized (e.g., Snell et al. 1997), every month that goes by in which the lizard does not enjoy the protections of the ESA pushes this rare reptile closer to extinction.

The Judgment Fund has no fiscal year limitations, and there is no need for Congress to appropriate funds to it annually or otherwise. Moreover, disbursements from it are not attributed to or otherwise accounted for by the agencies whose activities give rise to awards paid. This should be a matter of public record, because both the costs of litigation and the payout sums are funded with taxpayer dollars. Average attorney fee per suit \$112,000.

Oregon's Budd-Falen Law Offices recorded more than \$4.7 billion paid out from federal judgment funds and nearly

42,000 claims between 2003 and July 2007. Litigation environmental groups enjoy a steady stream of tax revenues thanks to this double-dipping scheme. If a green pressure group wins, it can recover attorney's fees and costs from the losing government agencies. If it settles for a sum that substantially favors its side, it recover attorney's fees and costs. The Judgment Fund for litigation does not even pretend to benefit tax payers.

Congress has the authority to close this litigation fund. Why doesn't it? Americans need to realize we are being duped, extorted, and embezzled by environmental groups, attorneys and Congress.

Environmental and animal rights activists have exploited a loophole in the EAJA and through round-robin litigation they build their organizations through continued filing of law suits.

The Government Litigation Act will limit the use of EAJA to only those who can prove they have a direct and personal monetary or property interest, suffered personal injury, or are likely to suffer irreparable harm. Reimbursement of legal fees under EAJA will be curtailed if the claimant has unreasonably protracted the proceedings, been oppressive or acted in bad faith, or has utilized pro-bono. Moreover, all attorneys' fees will be capped at \$175 per hour, and limited to \$200,000 for any single law suit, and no more than three EAJA awards in any calendar year can be awarded to the same claimant. All payments under the EAJA shall be reported, and a searchable database created identifying the amount, and to whom the funds were paid, including sealed settlement agreements, the agency sued, hourly rates of expert witnesses, and related costs, the names of presiding judges in each case, and their basis for finding the positions of the agency concerned was not substantially justified.

A GAO report of EAJA payments since 1995 will be requested under this form of legislation. It is time to shut down the litigation machine! Obama and his friends have found a cash cow.
